Notes on corporate membership

Corporate or group membership is available to any reputable private or public organisations, businesses or voluntary groups who wish to avail of facilities and services of Woldingham Village Club. The Club currently allows each organisation up to 30 corporate members at any one time. Occasionally, it may be possible for an organisation to negotiate with the Club for a larger number of corporate members. The Club will provide corporate membership cards for the organisation's named corporate members.

Corporate members are entitled to the same facilities and services as individual full and associate members of the Club. However, they do not enjoy voting rights in relation to the Club Committee nor may they invite children or minors into the Club without prior permission. Corporate members are expected to abide by the rules of the Club as amended from time to time. Individuals may be required to leave the Club for any improper behaviour.

The annual corporate membership fee for up to 30 corporate members is £150.00 for one calendar year, £275 for two years and £375 for three years. There are no other administration fees. Membership fees should accompany the completed application. Cash and crossed cheques payable to **WSC Ltd** are acceptable. Cash may be handed to Club staff for which a receipt will be provided on request.

Corporate members may invite up to 2 guests at any one time into the Club. Fees for each guest are £1.00 per visit.
